

HISTORICAL MEMORY, LEGAL PRECISION, AND SELECTIVE NARRATIVES: GREECE'S 14 SEPTEMBER DECLARATION

On 14 September 2026, the Greek Ministry of Foreign Affairs commemorated the National Remembrance Day for what it describes as the genocide of the Greeks of Asia Minor, associated with the 1922 destruction of İzmir.[\[1\]](#) Türkiye rejected the statement as unfounded and recalled Article 59 of the Lausanne Peace Treaty concerning Greeces responsibility for acts contrary to the laws of war in Anatolia. This exchange shows that historical remembrance requires completeness, conceptual discipline, and legal precision.

The Historical Record of the Greek Occupation of Anatolia

The historical setting of the 14 September declaration cannot be confined to the events of September 1922. Greek forces landed at İzmir on 15 May 1919 following a decision of the Allied leadership at the Paris Peace Conference, and the landing developed into a Greek military occupation and advance in western Anatolia. Reports of violence prompted the Allied Powers to establish an Inter-Allied Commission of Inquiry in 1919. The Commissions report recorded violence and pillage against Turkish inhabitants of İzmir on 15 □□□□ May and found that Greek soldiers had participated, while military authorities had been late to restore order.[\[2\]](#)

A further Allied inquiry in 1921 concluded that, in the Greek-occupied parts of the Yalova □□□□□□ area, Turkish villages were being destroyed and the Muslim population displaced.[\[3\]](#) Toynbees contemporary observations and these inquiries demonstrate that the period cannot responsibly be reduced to a one-sided narrative of victimhood.

The destruction of İzmir in September 1922, frequently invoked as the defining symbol of this period, must also be assessed in the context of the Greek armys documented withdrawal strategy in western Anatolia, which involved the systematic destruction of numerous towns and villages. In this context, research by AVİM non-resident scholar Maxime Gauin, drawing on contemporaneous French, British, and American documentation, has challenged allegations of Turkish responsibility and advanced evidence pointing to Greek and Armenian responsibility for the fire.[\[4\]](#)

The Genocide Concept and the Lausanne Treaty Record

This documentary record also makes conceptual precision indispensable. The term genocide is not a general synonym for wartime suffering, forced displacement, or large-scale loss of life. Under Article II of the 1948 Convention on the Prevention and Punishment of the Crime of Genocide, it concerns specified acts committed with the intent to destroy, in whole or in part, a national, ethnic, racial, or religious group as such.^[5] The Convention postdates the 1919 conflict; it is therefore not invoked here retrospectively as a legal determination. A contemporary ministerial declaration cannot replace rigorous historical inquiry or legally disciplined assessment.

Article 59 of the Lausanne Peace Treaty records Greeces recognition of an obligation to make reparation for damage caused in Anatolia by acts of its army or administration contrary to the laws of war. Türkiye subsequently renounced its claim for reparation in view of Greeces financial situation.^[6] This provision should also be read within the wider Lausanne settlement. The settlement restored the Karaağaç area, near Edirne, to Türkiye as part of the territorial arrangements agreed with Greece. Although Article 59 does not itself identify Karaağaç as compensation, the territorial transfer has been widely understood as connected to the reparations compromise reached during the Lausanne negotiations. The arrangement illustrates that the peace settlement addressed the consequences of the Greek occupation through concrete legal and territorial arrangements, not through a one-sided memorial narrative. A credible public discussion must acknowledge this record and the suffering of all civilian communities. ^[7]

Selective Historical Memory and Regional Dialogue

Against this background, the principal concern is not commemoration itself but the transformation of commemoration into a selective instrument of interstate discourse. When historical tragedy is presented through an exclusive and legally imprecise victimhood narrative, it risks entrenching antagonistic perceptions, marginalizing the documented suffering of other civilian communities, and diluting the meaning of atrocity-related legal concepts. Greeces declaration invokes the duty to preserve memory and prevent falsification of history; those aims require inclusion of the occupation period and the contemporaneous international evidence concerning violence against Turkish and Muslim civilians.

Türkiyes response, by recalling Article 59 of the Lausanne Peace Treaty, draws attention to a treaty-based dimension absent from that declaration. Official commemorative discourse should therefore be grounded in comprehensive archival research and legal consistency, while academic and public debate should recognize the suffering of all civilian communities without converting historical memory into a source of contemporary antagonism.

Ultimately, historical memory deserves respect only when it is comprehensive, evidence-based, and legally precise. Omitting documented violence against Turkish and Muslim civilians during the Greek occupation of Anatolia is incompatible with the principle that history must neither be erased nor falsified.

A balanced approach, attentive to the full historical and treaty-based record, is essential

for scholarly integrity, reconciliation, and regional stability.
